

# Libsyn Affiliate Program Terms and Conditions

**Last Updated: September 25, 2025**

Welcome to the Libsyn Affiliate Program ("Program"). These Terms and Conditions ("Terms") apply to your participation in the Program and govern the process of referring new hosting clients ("Referrals") to Liberated Syndication ("Libsyn," "Company," "we," "us").

By applying to and participating in the Program, you ("Affiliate," "you") agree to be bound by these Terms.

## 1. Enrollment and Approval

All Affiliate applications are subject to approval by Libsyn at our sole discretion. We reserve the right to refuse or revoke membership at any time if we determine that your website or promotional methods are unsuitable for any reason.

## 2. Payouts and Referral Fees

**2.1 Payout Structure:** The Company will pay the Affiliate a one-time, flat-rate Payout Fee ("Payout") for each qualified Referral. The Payout amount is determined by the hosting plan selected by the referred customer:

- **\$20 Payout** for any new customer who signs up for a Libsyn hosting plan priced at \$15/month or higher.
- **\$10 Payout** for any new customer who signs up for a Libsyn hosting plan priced at \$7/month.
- **\$0 Payout** for any new customer who signs up for a Libsyn hosting plan priced at \$5/month.

**2.2 Payout Trigger:** A Payout is earned only after a referred customer has successfully made **two (2) full months of payments** for their hosting plan.

**2.3 Payment Schedule & Method:** Payouts are processed monthly. Affiliates must have a minimum balance of **\$50** to be eligible for a monthly payment. All payments will be made via PayPal.

**2.4 Affiliate Responsibility:** Affiliate is responsible for providing and maintaining an accurate and active PayPal account for payment. Failure to provide accurate information may result in delayed or forfeited Payouts.

### 3. Qualified Referrals

A new Libsyn account is considered a qualified Referral when a customer:

1. Uses your unique Affiliate promo code during signup.
2. Successfully completes the signup process for a new, paid Libsyn hosting plan.
3. Maintains an active account with a current billing status for a minimum of two (2) consecutive months.

### 4. Payout Reversals

Libsyn reserves the right to reverse or withhold Payouts in the following circumstances:

- If the referred customer's account is not in good standing.
- If the referral is found to be fraudulent (e.g., involves false information, stolen credit cards).
- If the referred customer issues a chargeback or receives a refund for their first two months of service.
- If the Affiliate has violated any terms of this agreement.

### 5. Affiliate Responsibilities and Restrictions

#### 5.1 Promotion:

You are responsible for promoting Libsyn using the approved assets and your unique Affiliate promo code. You may not misrepresent Libsyn or its services.

#### 5.2 Prohibited Activities:

You may not engage in any of the following promotional activities:

- Spamming (unsolicited commercial email).
- Using misleading advertising or making false claims about Libsyn services.
- Bidding on Libsyn-branded keywords (e.g., "Libsyn," "Libsyn hosting") in any pay-per-click advertising platform.

## 6. Term and Termination

Both the Affiliate and Libsyn reserve the right to terminate this agreement at any time, with or without cause, by providing written notice to the other party. Upon termination, you must cease all promotion of Libsyn and remove all affiliate mentions and assets. Any outstanding, qualified Payouts earned prior to the termination date will be paid in the next payment cycle, provided you have not violated these Terms.

## 7. Relationship of Parties

Nothing in this agreement shall be construed to create a partnership, joint venture, or employment relationship between Libsyn and the Affiliate. You are an independent contractor, and you are solely responsible for any and all taxes associated with the Payouts you receive.

## 8. Modification

Libsyn reserves the right to modify any of the terms and conditions in this agreement at any time. We will provide notice of any changes. If any modification is unacceptable to you, your only recourse is to terminate your participation in the Program. Continued participation in the Program following a change will constitute your binding acceptance of the change.
